with me is Detective Ojeda, 1795. And this is related to case number 2280828. Um, we are currently here at the Sarasota County Sheriff's Office,
Criminal Investigations. Um, and we're here with, uh, David Gregory. All
right, David. You have the right to remain silent. You understand that?

DG: [Nods head up and down].

NK: Anything you say can and will be used against you in a court of law. Do you understand that?

DG: [Nods head up and down].

NK: You have the right -- is that a yes or?

DG: Uh-huh.

NK: Okay. If you could say yes or no --

DG: Okay. I'm sorry.

NK: -- so we can -- so we can hear you.

DG: I'm sorry.

NK: Uh, you have the right to talk to an attorney, have him or her present with you before and during questioning. You understand that?

DG: Uh-huh.

NK: If you cannot, uh, if you cannot afford to hire an attorney, one will be appointed to represent you at no cost to you, before and during questioning, if you wish. You understand that?

DG: Yes.

NK: Okay.

DG: I'm sorry.

NK: You can decide at any time to exercise these rights, not answer any -- not

answer any statements -- or any questions or make any statements. You

understand that?

DG: Yes.

NK: Okay. Do you understand each of these rights that I've explained to you?

DG: Yes, I do.

NK: Having those rights in mind, do you wish to speak to us now?

DG: I don't know what to do. I mean, uh, yeah, I will at the moment. Sure, I will.

NK: Okay.

LO: Okay.

NK: Um, okay. I -- I know -- I know that you have history with this -- this --

DG: Yes, sir.

NK: -- okay, um, that you were dealing with today. Um, what I want to first talk
to you about is what happened today. And then, we're gonna go back, and
we're gonna talk about the past that you might've had, the other -- other
incidents that you might've had with him. Okay. So, today, can you just go
ahead and tell in your own words.

DG: Uh-huh.

NK: What -- what time was it?

DG: Uh-huh. We were --

NK: And what happened?

were walking the dogs early morning poop. Um, and we were down on the second dock, and we saw him come out. He came out to the street, walking. And so, we just kept on going the direction we were going because you know, with the last prior two times with him, we didn't want a run-in. And, um, he went down that street, and came back up, walked down the street, walked down back past us, which was out of his way. And, I was with the chihuahua, and Amy was with the terrier. And he walked by, and he spit at me twice. And I didn't say a word. I just let him go. And then, uh, he walked past, and he yelled something. I don't know what he yelled,

but that got my chihuahua to move toward him. And when I went, I grabbed the chihuahua. It was freaking out 'cause I was in trouble. And by that time, he had come up to me and had me by the shirt. He grabbed me by the shirt, and hit me in the chest. And I pushed him away. And that's when I got the pistol and shot him. (unintelligible). That was it.

NK: Okay.

- DG: He came back out of his way. He spit at me twice. Walked past, said

  something. I have no idea what it was. And then, things escalated from
  there. And here we are.
- NK: Okay. You guys step out of your home. Um, you cut -- you cut through,
  and you get onto Highlands. Okay. And you said the second block. What
  direction would -- once you step onto Highlands --
- DG: We went left. We had already made our right. We -- my dog, the terrier, is sick, so she won't walk far. So, we carry her to a certain point, and we sit her down every day, five times a day. She's diabetic. She sleeps. She poops. You know. And we walked down the street, make a left up our little alley there, and into our house. And that's -- we do that five times a day.

  We --

NK: Okay. Before -- did you -- at what point do you first see him today?

DG: Um, when he was, uh, well, coming around the corner walking down stairs.

There's a guy walking his dogs, and you can tell he -- he wanted some

business with him 'cause it was one of his neighbors. And then, we just

started walking, doing our normal walk.

NK: Okay. So, we're gonna go back -- we're gonna -- further back from that.

When -- when you said -- okay, so you're walking -- you guys are walking your dog, and you see another neighbor --

DG: Yes. It was --

NK: -- walking a dog.

DG: -- some guy with dogs (unintelligible).

NK: Okay. But you don't know him at all.

DG: I wasn't paying attention.

NK: But you see him. Then, you see -- do you know -- okay. The man that you were dealing with today, what -- do you know his name?

DG: I have no idea.

NK: You don't know who -- who he is.

DG: No. I know --

NK: Okay. But you --

DG: -- where he lives --

NK: -- you've dealt with him multiple times.

DG: I've had two -- two -- I've called you guys twice on him.

NK: Okay. Describe him for me. Describe what he was wearing today.

DG: Today, he was wearing a hoodie with a baseball hat, um, dark hoodie, gym shorts and tennis shoes, as far as I remember.

NK: What color was the hat?

DG: I wanna say black.

NK: Okay. And you called it a hoodie. You said a dark thing.

DG: Yes.

NK: Okay. Um, describe his, uh, physical size.

DG: 6' 2", 215, lifts weights, big boy.

NK: So, he's muscular you would say?

DG: Oh, yeah.

NK: Okay. Any -- any -- any identifying marks, maybe glasses, tattoos?

DG: Yeah. He had glasses.

NK: He --

DG: He was wearing glasses.

NK: What kind of glasses?

DG: Wire-framed glasses. All I know. clear.

NK: Oh, like prescription glasses?

DG: Yeah. Yeah.

NK: Okay. Okay. So, you see this other man walking his dog. Um, and then, is that when you seen this man -- this man?

DG: [Nods head up and down].

NK: Okay. His name is Steven --

DG: Okay.

NK: -- if you didn't know. Okay. Let's describe him as Steven.

DG: Okay.

NK: Okay. Um, where -- when -- when you see Steven, where -- where is he at when you first see him, and -- and this man with the -- with the other dog?

DG: They're walking down the side street, and I'm like -- like, we come out here between our place.

NK: Yeah.

DG: We make a right, go down (unintelligible) there's a street that goes straight down.

NK: Yeah. Westview.

DG: Right. Okay. Westview. He was walking down that street.

NK: Okay. You seen Steven going towards --

DG: Yes.

NK: -- the man --

DG: Yeah.

NK: -- that was walking? Okay.

DG: And the guy made the corner, then Steven came back up, and went down
the street 'cause the next time I saw him, he was coming down the street
from that way --

NK: Yeah.

DG: -- which is fine, you know, just -- I was hoping he was --

NK: Okay.

DG: -- out just going for a walk.

NK: So, as you -- now, he's getting close to you guys, what is -- what happens then?

DG: He gets close to us. He walks past us to the end of the street, at the corner.

We don't say a word. We're minding our dogs in these people's yard. He

walks past, spits. I stop and look. He goes [sound effect], spits at me

again.

NK: So, when he walked away, he gets to one driveway away.

DG: He turns around.

NK: And then, turns around and comes back.

DG: And starts saying something to me. That's when the chihuahua started moving. So, I went up like three or four steps to grab the chihuahua, and he came to me. Yeah. He --

NK: How --

DG: -- started moving.

NK: -- how close does he get to you on the first approach?

DG: He's grabbing me. He grabs my shirt, punches me in the chest.

NK: He doesn't get in your face, and then, grab you, or does he grab you first?

DG: It -- it was simultaneous.

NK: Okay.

DG: Uh, he came up. And I was like, "Dude, get away from me." And he grabbed me, pop, and that's when I went back and boom (unintelligible).

NK: So, he grabs you by the shirt.

DG: Yeah.

NK: Okay.

DG: Yeah.

NK: Okay. With one hand, two hands?

DG: One hand.

NK: Okay. And then, he punches you?

DG: He hits me -- just, not really, but he hits me. Yeah. He hits me with his right hand in the chest.

NK: Okay.

DG: He's got ahold of like, here. He hits me.

NK: So, he got ahold of you with one hand.

DG: I push him back. Yeah.

NK: And then, he punches you with the second, in the chest.

DG: [Nods head up and down].

NK: How hard was it?

DG: No idea. I notice that he punched me. Um, does it hurt now? No. My
shoulder is killing me. Does that have something to do with it? I don't
know, but, uh --

NK: Okay.

DG: -- but, uh --

NK: So, he punches you, and then, what?

DG: And then, I shot him.

NK: Okay. At what point do you pull out your pistol?

DG: After he hits me. When he hits me, I'm coming back. I'm like, "Stop." And he's still real aggressive, so I was just like --

NK: Okay. Um, and when he punches you, and you pull your pistol out, are you

NK: Okay. We were just -- I -- I'm -- I'm just clarifying because I got a word that

you had said to a neighbor to call 911. That's --

DG: No. I screamed that at my wife.

NK: -- and you said it was your idea to call 911 to your wife?

DG: I guess I told her, yeah. I was freaking out, man. I don't know, but I -- I did.

DG: Well, we mailed it off. I don't -- we -- we put it in the mail, but I never--

NK: Okay.

DG: -- got it back.

NK: Uh-huh. Okay. Just, uh, describe to me his -- his -- the other incidents you had with him in the past. Like --

DG: The first time, he -- so, he comes out of his driveway. It's 10:30 at night.

NK: How long ago was that?

DG: Um, six, eight months, a year ago. Um, he, uh, he got his flashlight on like he's, you know, YouTube or TikTok-ing or some of that shit. I don't do that stuff, so I was just like, uh, and I kinda laughed, and I told my wife. I said, "Just keep moving. He must be filming TikTok or something." And then, he turned his phone off. And he came back, and he got in front of me. He started swinging. "You wanna fucking do something about it, buddy? You wanna fucking do something about it?" And I said, "No. I sure don't, dude." And I said, "Come on, baby. Let's go." And we went home, and home quickly. And then the next time we saw him, he came up. He did spit on me. Um, I was --

NK: Another encounter?

DG: Yes. This is the second --

NK: Second time.

DG: -- encounter.

NK: Okay.

DG: That's when I, uh, and he came out. He --

NK: He spit?

DG: -- he walked past, turned around. He's all pissed off about something, God knows what, and spit on me. I told Amy "Get the dogs. Let's go home.
Let's go home." And, uh, I told him, I said, "You know, we don't want no trouble, dude."

DG: Just go home.

NK: -- spit on you or --

DG: He spit on me.

NK: -- spit in your direction?

DG: Yeah. He spit on me.

NK: Where did it go -- land on you?

DG: Being hurt, being crippled. I mean, I can't carry a gallon of milk, man. If somebody hits me, I'm done, dude. I'm scared of people.

NK: Yeah.

DG: I'm -- I'm scared. I don't know. I -- I've got this disc and my injuries

(unintelligible). I've talked to the surgeons, and I've talked to my son. And

it's bad. I got nowhere to go but down with this thing. I can't afford the

operation.

LO: Yeah. What operation do you need?

DG: Oh, they've gotta go in and put all six discs back in. And they gotta fuse 5 through 3.

LO: Where's that? In your back or --

DG: In my neck.

LO: In your neck.

DG: Yeah. It controls this and your legs. I didn't know all this 'til I got hurt. So,

I'm -- I'm -- I don't even drive a car very often. I'm scared of getting in a car

wreck. If my neck snaps, I'm -- I'm done.

NK: Yeah.

DG: I'm done.

NK: So, after that first encounter --

DG: -- (unintelligible).

NK: -- when did -- you started carrying -- were you carrying --

DG: Uh --

NK: -- on that first encounter or you always carry or?

DG: I always, uh, would carry for, uh, because we live across the street from Oscar Scherer.

DG: And there are, uh, coyotes and bobcats around there, just rampantly. And you're always chasing off coyotes.

LO: Now, when you carried your gun, did you carry it ready to go with one in the chamber? I mean, how did you --

LO: Sure. And, uh, when you ended up, today -- with this encounter today, and you ended up shooting Steven, how many times did you shoot? Do you --

DG: Just the one.

DG: Yeah. He wouldn't -- he wouldn't let up. I'm just like, "Dude." I mean, we're just walking dogs, just walking dogs.

LO: Have you heard of Steven having any encounters with anyone else?

DG: With everybody in the neighborhood. You've got records thicker than that pad.

NK: Do you have any --

DG: If somebody would've done their goddamn job, I wouldn't be talking today.

NK: -- do you have any -- do you have any, um, names of any people that you know that had -- had --

DG: I don't know any name I don't know my neighbors that closely. I don't know their names. Um, I can tell you who they are, what they look like, but everybody's had encounters with the guy. You guys are always out there.

I mean, I'm --

LO: Well, sometimes people will have --

DG: -- telling you --

LO: -- encounters, but they won't call.

NK: Yeah.

DG: No. I seen --

LO: You know what I mean?

DG: -- the -- the Sarasota Police cars are out there. And you know, it's just -- whew, you have to give me a second or two.

NK: Sure.

DG: Yeah. The fucking guy, he was standing out there last week yelling at a couple of gay guys live there. And then, one guy walked by said, Oh, he was just standing out in the street going, "You fat fucking bastard. I'm gonna kill you. You fat bastard." And I was like Whoa, just – me and Amy

<u>I don't know if he does it. He did that. I seen him do a lot of stupid shit. I</u>

mean, you guys are always out there.

LO: Who does he live with?

DG: I mean, he -- his -- his parents live in town, from what I was told by the

neighbors, and they shipped him to the grandparents. And the

grandparents are snowbirds, so for six months, he's unsupervised. And in
those six months, it's pretty wild.

NK: Yeah. Yeah.

DG: And that's all I know.

LO: Okay. Can you do me a favor? Um, David, can you just stand up here for me? We need to take a picture of you real quick. Front, back and of your hands, which we got Forensics out there working. Can you step a little bit back further? Um, my camera on my phone is -- look up for me. Look up for me. Okay. And -- and turn around for me. I just don't want to forget to do this. Okay.

NK: Back of his hands.

LO: Yeah.

NK: Uh-huh.

LO: Let me see -- and your palms, sir, please. All right. Thank you. You can have a seat again.

NK: We're almost done. David, was there -- is there anything else that you think is important for us, um, as investigators --

DG: I wouldn't know, man.

not to pay attention. You know, even the time that he came out and spit on
me, I was trying not to pay attention to the guy, you know. And when he
