NK: All right. Today's date is October 27th, 2022, at approximately, um, 1 -- uh,

139 hours. I'm Detective Nate King, ID 2399. We're currently here at 1845

Highland Road in Osprey, uh, with Kelsie. Go ahead and state your full

name for me.

KL: Uh, it's Kelsie Eden Lloyd.

NK: And your birth date?

KL: 11/14/89.

NK: Okay. Um, and this is regarding the case number 22-80828, an incident that occurred on September 24th, 2022, involving a, uh, shooting, um, that occurred out front of the home of, uh, 1850 -- uh, 1800 block of Highland Road.

Um, uh, Kelsie, can you go ahead and just raise your right hand for me?

Do you swear the statement you're gonna give today is the whole truth and nothing but the truth?

KL: Yes.

NK: Okay. Um, on the -- on the day of, uh, September 24th, were you home at the time?

KL: No.

NK: Okay. Um, and then you said that you, uh, learned about the -- an incident that occurred in front of your house --

KL: Uh-huh.

NK: -- by somebody that called you.

<u>Match my dog. And that's when I first became aware. I think it was about 8 a.m., after the incident.</u>

NK: Dayna. Is that Purcell?

KL: Yes.

NK: Okay. She also called 911.

KL: Yes.

NK: She text you --

KL: Yes.

NK: -- and told you that something happened out there?

KL: Yeah. And she just wanted me to see where my mom was, to make sure she wasn't outside walking my dog.

NK: Okay. Did Dayna say anything about what happened? Or, what was her words?

KL: Yeah. Like, she was just like a lot cursing. She's from Boston. So --

NK: Okay.

KL: -- just a lot of cursing and pretty much just like she killed him -- or, "He killed him; he killed him," be like --

NK: Did she say names?

KL: Uh, she says, "Dave". Yeah. But, I mean, I pretty much knew because, like

I said, the week before the other incident that happened with all the cops

being in the neighborhood, we had all been talking about it --

NK: Okay.

KL: -- um, which would have been when -- the reason why I'm concerned is because that's when he made the statement to me

NK: Okay. So he's -- she said, "He killed him." And then anything else about what she might have seen, um, anything --

KL: Um, no, no. She was just like -- she was -- she was just like, "It was like

7:00 and," she shot -- "he shot him." And, uh, then it was almost like just

geared towards my mom, like making sure my mom wasn't out there. And

then I, you know, I couldn't get in touch with my mom, so that's really what

it turns --

KL: -- to.

NK: Okay. Um, and how do you know Dave? Do you -- do you know his wife,

too?

KL: Amy? Yeah. Um, I actually lived beside them. I lived on that back road
with --

And, yeah, so, I mean, neighborly. Like, he's walked my dog for me before
when I've been, um, gone for a longer -- like, extended day; um, but like
very, very, like, surface level, very, just like neighbor vibes. Like, hey, how
you doing? What's going --

KL: -- going on? I didn't even know what they did for work. I just knew he was home all day, every day, but --

NK: And how do you know Steven?

KL: I do not know him. I only was aware of him because of my client Erica

Garland, which is his older cousin.

NK: Okay.

KL: So --

NK: You never had any run-ins in the neighborhood with him, either with talking to him or --

KL: Never seen him, ever.

NK: Okay. Never seen him.

KL: Which is why --

NK: Okay.

KL: This is why it's all weird.

NK: When Dayna text you that David had -- had killed him, did you know who --

KL: Oh, yeah.

NK: How'd you know who he was?

KL: Um, because this has been commentary through the neighborhood of when

it -- he would get the police called on him quite frequently by his neighbors

down there.

NK: Steven?

KL: Yeah.

NK: Okay.

KL: Steven did. Um, and I later learned that it was my client's cousin so,
therefore, I then became more aware of, like, when things were going on. I
would just say, hey, just so you know, the cops are here. Like, make sure
your family knows so that they could check in on them. Um, you know,
like, it just became conversation in the neighborhood and, like, of -- of who
really was the person that was constantly getting the police called on him --

NK: Yeah.

KL: -- or more frequently than we would ever see police anywhere else for any other reason. Um, so we kind of -- we kind of knew. But from that very last time that it -- it got called, which I believe was like within seven days of the shooting --

NK: Okay.

KL: -- um, we were talking about his state of mental health. So --

NK: Who? You -- between you and --

KL: Me, Dayna, and I think her name is Sherry. Um, so it was just a few of the --

KL: -- dog-walking --

NK: -- down the street?

KL: -- neighbors. Yeah.

NK: Okay.

KL: We all kind of walk in groups and walk the dogs sometimes.

NK: And then what was your conversation with his mental illness? Like, what – what'd -- what'd you know of him or is it --

KL: Um, this is from his cousin. Um --

NK: Okay.

KL: -- that, you know, that he had some mental issues. She didn't really say,
but I'm empathetic to it because of my dad's bipolar.

NK: Okay.

KL: Um, and this could have honestly, easily, have happened to him which is why I was always so in tune with it 'cause I was sensitive to it. And so me and her would talk about it. And she didn't really specify if it was schizophrenia or whatever.

NK: Okay.

ML: But we would have conversations because we've had to try to Baker Act
my dad. And I've walked her and the family through some of those steps,
um, you know, was giving her information to tell her mom, which I know
her mom as well, um, Freida. So -- which is his aunt. Um --

NK: Okay.

KL: Uh, her mother is the house that they live in, so that -- this is like the

grandparents of my client. And that's how they're cousins. So it's just, you

know --

NK: Okay.

KL: -- big Italian family.

NK: So would it be, um, Steven's parents, uh, either Paula or Steven? Is that --

KL: No.

NK: How --

KL: I believe it --

NK: How they're related to --

KL: -- to be Paula's sister.

NK: Sister. Okay.

KL: And, um, and the niece that I know.

NK: Okay. She comes here. Okay.

KL: Yep.

NK: Um, do you know of any incidents, um, where -- where Steven has, you know, uh, maybe confronted other neighbors or any -- anything like that?

KL: I mean, this is only just like gossip --

NK: If you could --

KL: -- I guess.

NK: Yeah. I'm looking at any --

KL: He said/she said. But it was -- you know, there's been times where he

allegedly spit on another neighbor in those -- in that little housing

development --

NK: Okay. Okay.

KL: -- um, he lives in. But to my knowledge, it was never really outside of his little block --

NK: Okay.

KL: -- because, like I said, I've never seen him. I walk day and night. I, you know, wake up early and I go to bed late. So I've never seen him out. But that's really it. Them other issues, because of Erica, I was aware of, like, what happened internally with the family.

NK: Okay.

KL: You know, like maybe some altercations with being able to -- not being able to control him and him being a little scary to the older --

NK: Yeah.

KL: -- family --

NK: Yeah.

KL: -- members. But --

NK: And, uh, what was Erica -- that was -- your client is Erica?

KL: Yeah. Erica Garland. And she's the one that's been like really wanting me to talk to you guys just because of how it happened.

KL: It's like --

KL: -- my premonition came true six days later, which is why it's --

NK: Well --

KL: -- awful to me.

NK: -- uh, the father had, uh -- Steven had -- had spoke to me and said that --

KL: Yeah.

NK: -- you -- and then I seen that you had called me. Um, so once you mentioned that --

KL: Yeah. And, I mean --

NK: -- um --

KL: -- I wanna help. I mean, this is --

NK: Yeah.

KL: -- just tragic, a tragic way for a really tough situation to end.

NK: And what do you know about David and Amy? Like, what -- what are they

like? What's -- anything with -- any -- any confrontation with them with

other people in the neighborhood or --

KL: He gets worked up about things, you know. There was a girl that lived in this house, um, who had some issues like drinking and being drunk on the front yard or whatever and there would be some drama. Um, and he would kind of get worked up about any -- like -- kind of like neighborhood watch type of vibes, you know. But he kind of made it a little bit more like -- I don't know. He was more aggressive. I don't know. I've --

NK: His business, maybe?

KL: Yeah. He made it his business, like. And that's literally verbatim what I told
Erica about the last situation, is like he's kind of making it his business to,
like, watch this kid.

NK: Okay.

KL: And -- and he did that with kind of everybody.

NK: Do you know if his, um -- any -- do you know of -- of his confrontations with

Steven in the past? Do you know about those?

KL: No. No. 1 --

NK: Okay.

KL: -- only recently just heard about the --

NK: Okay. And the --

KL: Apparently he was, uh -- uh, confronted before. But again, I've walked with

Dave and he's never mentioned anything prior.

NK: How long ago was this are you talking or you walked with him?

KL: That was -- pssh (phonetic). Okay. So I would say maybe a week to two weeks before the incident, max.

NK: And Amy?

KL: Uh, no. This was like in the middle of the night. I was walking my dog at like 12 a.m. And Dave scared the crap out of me 'cause he was walking as well and he didn't have a flashlight or anything.

NK: Oh, okay.

KL: And so we ran into each other out in the pitch black. And then we just ended up walking together, uh, this circle, this small circle around the houses. And we were just talking, you know --

NK: About --

KL: -- while we were walking.

NK: Okay. He never mentioned Steven?

KL: Um, like, yeah. He -- he called him like -- you know, like a knucklehead or

just like whatever. Uh, like he's -- he's equally aggressive and prejudice

about a lot of things and that's why, like, I really didn't take a ton of note of,

like, that conversation that night 'cause he's made racial comments and --

NK: Yeah.

KL: -- prejudice type of things where like I -- I like -- I don't entertain.

NK: You don't wanna -- yeah. I --

KL: So I don't even -- I don't even remark back to whatever he's saying. So

they'll be little snippy things like that. I mean, he'll just be like this

neighborhood's like going down the drain or whatever 'cause there's been
a few things that have been going on. And he's -- he made comments of
like, "I'm ready to F'n move." And he curses a lot, uh, which again is not
my personality and I don't like listening to the aggressiveness of it.

NK: Yeah.

KL: So, you know, like me and him, like, he's not my favorite person. But

because of our dogs and he loves -- I mean, he'll come up to my window

and like interact with my dog through the window.

NK: Okay.

KL: That's how much he's like an animal lover. So, on that note, like, I was fine
with him. But as a person, like, I would --

NK: Yeah. Yeah

KL: -- steer clear of him.

NK: Did he ever talk about his, uh -- any kind of disabilities that he might have,
any physical ailments or struggles or anything with --

KL: I think he did, but when I first moved in, you know, about two years ago,

like, when I lived back there beside him. Um, but, no, not really. He mostly

just talks about his son, like his son being in the --

NK: In the -- in the --

KL: Yeah.

NK: Uh -- uh, military?

KL: Seals. Yeah.

NK: Okay.

KL: Um, and then he talks a lot of politics and stuff like that, which, again, I
wasn't --

NK: Okay.

KL: -- wasn't into. But --

NK: But nothing of his physical --

KL: Uh-uh.

NK: Nothing. Okay.

KL: No.

NK: Um, anything with Amy? You talk with Amy about any -- anything regarding the neighborhood or --

KL: No

NK: -- their concern about anything happening?

KL: It was usually just pleasantries with Amy. She's very quiet and smiley and happy and he's like the polar opposite. Well, he's pleasant, too --

NK: Yeah.

KL: -- sometimes. But she was mostly just like that's all you really get from her and very short conversations, um --

NK: When you --

KL: -- but, yeah.

NK: When you were walking with him at night two weeks ago, um, you said he didn't say anything about Steven?

KL: No. Like --

NK: Any -- any kind of fears that he had about anything going on in the neighborhood that, you know --

KL: And I feel like that would have been the time 'cause I mentioned like how spooky and how dark it was when we were walking.

NK: Okay.

KL: And, like, I mean, if he had gotten into an incident with him like -- like what I was told it was in a nighttime experience, he didn't mention it at that time.

KL: So, yeah. No. We just were talking about drama that was going on in the neighborhood and he gets all fussy about it, but nothing like --

NK: Okay. Nothing he was concerned with. Never mention, uh --

KL: Something that --

NK: -- maybe concern --

KL: -- he got hit?

NK: -- with -- about Steven even coming up to him or anything?

KL: Well, just -- he just basically makes it known that, like, he carries a weapon.

And if anybody --

NK: Okay. So he did --

KL: -- tries anything --

NK: Is this when he said -- made the statement about Steven?

KL: No. It was -- it was, um --

NK: Okay.

KL: -- the day that the -- the police were actually actively outside still.

NK: Okay. I'll go over to that in a minute. But --

KL: Okay.

NK: So when he does -- he does talk about he does carry --

KL: Yeah.

NK: -- a gun. Does he ever say why or for whatever --

KL: He just --

NK: -- reason? What does he talk about when he says he has a gun? Like --

KL: Like, I -- I kind of like characterize it as just like my right banter type of deal.

<u> Like --</u>

NK: Okay.

KL: If --

NK: So he's a proud gun owner would you --

KL: Gun, yeah

NK: I don't wanna put any words in your mouth, but is it like --

KL: Yeah. Like, he's--

NK: -- to speak of it.

KL: Like he --

NK: He's very --

KL: -- prides himself.

NK: -- open about --

KL: Very, Yeah.

NK: Okay.

KL: Like, you know.

NK: You said he was into politics, so I'm sure that's a way of --

KL: Yeah. Like --

NK: -- talking

KL: So it would just come like, you know, this is my rights. I have video, like.

And he was not afraid to tell you that he does. And he's not afraid to tell

you, like, that he's not afraid to use it, you know. Not like in an intimidating

way. But if he was talking to a less confident person, it would probably be intimidating.

NK: Yeah. Okay. Okay. So tell me about, um, when he mentioned something about Steven and -- and about having a gun.

KL: So this -- I only really wanna talk about this most recent time 'cause that's

the time that it caused me to call Erica --

NK: Okay.

KL: -- was the first. Um, she had made other comments in the past --

NK: About --

KL: -- about it.

NK: -- Steven.

KL: Yeah. About Steven, specifically. Like, just passing, again, like, more or less, an aggressiveness. Like almost like he's like a -- a rotten kid, you know. That you wish you could, like, you know -- I don't know -- put a hurting on or like, you know, like discipline him, almost, like.

NK: Okay. Okay.

KL: Almost like just like annoyed neighborly -- like somebody needs to get this kid. But he's always made like a -- he has always made reference to Steven throughout these last two years, but, again, in a more general sense, more or less, like -- again, it just felt like that banter of like his just aggressive nature. Like, that he doesn't have patience for people like Steven who are showing out in the ways that he would show out with other neighbors and just, you know.

NK: Okay. But the comment you're gonna talk about --

KL: Is --

NK: -- you said it was different.

KL: Yeah. This one--

NK: Okay.

KL: -- was significantly different in the fact --

NK: So what does he -- when does he say this?

KL: This is -- I wish I knew the date of like when he got called on the week

before. But it was that day, daylight. It was --

NK: Well, Steven got called on?

KL: Yeah. Because he wouldn't move his vehicle. They were trying --

NK: Okay.

KL: -- to do something with the gravel back there.

NK: His mom came out there and another neighbor.

KL: And he pushed her and --

NK: Yes. Okay.

KL: Yeah. So it was that day. And so that's what we were all talking about.
And I was shocked that he pushed his mom, but -- but I also know how,
like, those things work. It's like a autism thing. When you get -- feel like
you're getting pushed into a corner by authorities, start screaming and --

NK: Uh-huh.

KL: -- act out. So I have a understanding of those things. So I was like trying
to talk to the neighbors about that and, like, it's just a shame 'cause they're

the knowledge I knew of, uh, what Erica was telling me. So, anyway, I don't remember if we had walked away separately or if it was later that evening that I was walking with Dave. And I feel like Amy was there, but the dogs -- they've got two different dogs. So I feel like she was just like either further down or she had -- sometimes they'll leave each other and she'll walk back in and he'll walk one of the dogs longer.

NK: Right.

KL: So, anyway, one way or the other, I ended up with him by myself. And he basically just said like -- I don't remember if it was because either the cop cars were still out or why it came up. But he just basically just said like, "That kid's got one time with me and I'll put a bullet in him." And when he said that so specific to me, that was way different than all the other like passive comments. So I called Erica like (sound effect). I came inside immediately and called her. And I don't know if that was like me just being like too, uh -- uh, at first, it felt like I was being too, like, dramatic. It felt like I was being like -- I don't know -- freaked out about something, maybe I was being like -- I don't know. I just -- I felt --

NK: Yeah.

KL: -- like I was overreacting slightly, but I --

NK: So --

KL: -- called her.

NK: So you called her just to tell her of that? Like --

KL: I was like, hey, man, like --

NK: -- what the neighbor said?

KL: I was like I'm -- "I'm sure you probably know what's going on with your cousin down the street. The cops got called on him again. I just want you to know that that neighbor that I told you about" -- I have mentioned it to her before. I was like, "This time it just seems a little bit more, like, pointed and it almost seems like he has it out for him," was pretty much verbatim what I told her.

NK: Uh-huh.

KL: I was like, "I just have a really bad feeling. This guy carries a gun. I don't know why he has an issue with your cousin." I mean, I wasn't aware of any personal interaction between the two of them.

NK: Okay.

KL: And I was just like I don't know. Like, to me, it -- I think what I said to her was, like, "To me, it seems like he's looking for a reason."

NK: Okay.

KL: And that is truly how I feel about it. It just --

NK: Okay.

KL: -- feels like he was looking for a reason. I don't know.

NK: Okay. Um, and that was -- do you know how -- how long ago that was that

- with the pushing of the mom and then the moving of the car? Was that --

KL: Um, that was within like that same seven-day period from like backtracking from the shooting. I feel like it was --

NK: Okay. So probably --

KL: -- literally had been --

NK: -- within a week?

KL: -- a week. Yeah.

NK: Okay.

KL: That's why, when this happened, my heart just was like -- and again, I knew exactly who she was talking about when Dayna called me. I knew that she was talking about Steven and I knew she was talking about Dave. Like, there was just zero question in my head.

NK: And it -- and he never said anything about any kind of confrontations they've had together.

KL: No. And -- and I feel like he would have because --

NK: Okay.

KL: -- he loves talking crap, you know. He loves --

NK: Okay.

KL: Yeah. Anything that --

NK: Have you ever heard of any other neighbors talking about David talking about Steven and having a confrontation with him?

KL: No. Like, literally, it was just this week --

NK: No?

KL: -- that I heard about --

NK: So when somebody said they have had prior confrontations together, that would be the first time you would have heard that.

KL: Yeah. With Dave specifically?

NK: Yes.

KL: Yeah.

NK: Okay.

KL: Uh, to my knowledge it was only ever with his little community --

NK: Okay.

KL: -- that he would have issues. But, to my knowledge, Dave does walk at all times of the night --

NK: Uh-huh.

KL: -- morning. Could be pitch black and he's walking the dogs or carrying them around and --

NK: Okay.

KL: -- doing things. So it's just tough 'cause it -- it's, more or less, like a woman's gut feeling type of situation --

NK: Yeah.

KL: -- with that --

NK: Yeah.

KL: -- is a reason why I called her and, yeah, it's just --

NK: Okay.

KL: Again, it went along with his personality. It just was just one of those

things where I was like, ooh, that felt like serious that time. Like it just felt

like --

NK: But he never said why he would do that?

KL: Uh-uh.

NK: Just if he ever messed with him or --

KL: No. I would have told Erica like, hey, like he's messing with the wrong person, you know.

NK: Yeah.

KL: I would have told her because that's how I feel about him. I just feel like he's like slightly unhinged, you know.

NK: So -- 'cause you said, you know, that kid has one time with me like that what? If he ever --

KL: Like if he --

NK: -- tried something with him he -- he wouldn't even --

KL: He wouldn't hesitate.

NK: Wasn't hesitating. Okay.

KL: And that's some of the things that he said in the past. Like, he wouldn't hesitate. Like it --

NK: Uh-huh.

KL: Like you mess with --

NK: And he --

KL: -- me, you're gonna --

KL: -- get shot -

NK: He didn't say why. He didn't say there was a reason, like, to defend --

KL: No.

NK: -- himself or -- okay.

KL: Uh-uh. No. 'Cause like I said, if I felt like, uh, there was anything that had happened between the two of them, I would have told Erica just because --

NK: Uh-huh.

KL: -- I -- that's like my only link to actual family. The grandparents haven't been here, so I would always tell her.

KL: 'Cause I think they're --

NK: Have you ever spoken to the grandparents?

KL: I think I've seen them out a couple times recently. I wanna say hi, but, you know --

NK: Well, as of after the incident.

KL: Yeah. No. Never --

NK: Okay. And prior to that, ever -- okay. Ever spoken to the mom?

KL: Uh-uh.

NK: Paula? Do you know her? Ever met her?

KL: No. Uh-uh.

NK: Even Steven, the father?

KL: (No audible response).

NK: No?

KL: Uh-uh.

NK: Okay.

KL: No. To my knowledge, they weren't in great terms with their son at the time, so --

NK: Uh-huh.

KL: -- they hadn't really been around like that lately.

NK: Okay. Do you know of David having any issues with anybody else in the neighborhood, like, uh, any confrontations or any --

KL: Um --

NK: Or is this.

KL: Well, yeah. There's been --

NK: Is this isolated between David and Steven, like?

KL: No. Like he -- he tends to be a little, uh -- well, he has had other like runins, was like maybe cussing somebody out or telling somebody about
themselves. Uh, but again, that was all hearsay. Like, I was kind of
surprised there was like one or two other people. But, um, a guy that owns
a lawn company on the other side of the neighborhood I'm pretty good
terms with, and he has mentioned, you know, that Dave can get like a little
worked up.

NK: Yeah.

KL: But I don't know anything specific, honestly.

NK: Okay. Um, and I -- we can talk about your -- your Ring camera. So you've had -- you have a Ring camera out there that points out into the road.

KL: Uh-huh.

NK: Um, but you said you -- you don't pay any subscription anymore. You had a trial run.

KL: Yeah. It was free.

NK: Tell me about that. Like, how -- how long was that?

KL: Um, I would need to confirm, but I think it's a 30-day trial. I thought it was a 90-day trial. Um, I'm trying to remember. I put it in sometime in the summertime, so I would say it would be June or July is when I installed it myself.

NK: Okay.

KL: I was proud of it.

NK: Yeah.

KL: And, um, yeah. Like I -- I did have the recordings and I could remember
going back and looking at them like when it would save the Ring. That's
why I immediately hopped on and thought that I would have it.

NK: Yeah.

KL: And I didn't. Um, so I think it was just an expiration.

NK: So would have been -- so if you -- you already ran out by the time this incident happened.

KL: Yeah.

NK: Okay. So --

KL: Well, like I said, if the notification goes off, I can watch what happens live,

like I can literally link in through my Wi-Fi, you know. Wherever I'm at, I can
link into it.

NK: Yeah.

KL: But --

NK: But you never paid anything.

KL: Uh-uh. No.

NK: So they were only recording for you for 90 days?

KL: Yeah.

NK: And you don't know when that expiration would have been.

KL: Uh-uh. No. I'm gonna look it up and see if I can find --

NK: So if the --

KL: -- that out.

NK: August, July. So you had to have gotten it sometime early, middle of June.

Yeah. I had it since last Black Friday and then I just -- it took me a whole year to install it. I didn't install it until I moved to this unit. So that's why I'm thinking it had to be --

NK: Okay.

KL: -- June, July or August that I installed it.

NK: Yeah.

KL: I didn't install it right away.

NK: So when, um, Dayna called you, you looked immediately at your cameras.

And then you -- you couldn't -- you could see the live stuff. You seen our personnel out there at the time.

KL: Yeah. And, unfortunately, where my car was parked -- my car and then my mom's car -- and my car's pretty big. So --
