On 09/24/2022 at approximately 0720 hours, I was dispatched to 1855 Highland Rd Osprey, FL 34229 in reference to a suspicious incident involving the sound of gunshots heard. Upon arriving to the scene, the subject was found lying in the ditch on the cross streets of Highland Rd and Westview Dr.

The subject was removed from the ditch by Dep. Patella and Dep. Obrien to perform lifesaving measures until EMS personnel arrived.

The subject had a gunshot wound to the right abdomen.

I began getting information from Witness 1 Gary Osgood. I asked if he knew where the shooter went, and he did not know the direction. He stated, "I heard 2 gunshots, and someone say mother fucker".

Sgt. Leavitt attempted to make contact with a perosn of interest at incident.

Sgt. Surran and Lt. Kaskey arrived on scene and notified Criminal Investigations who responded and took over the investigation.

The scene was secured for preservation of evidence and a contamination log was started
