And they were doing some construction next door in the condos where -- I don't even know his name -- Colon --

PN: -- Steven lives. I've -- I've never met him. I don't even know what he looks like. Um, and he was causing problems with the construction workers. Dave was relating the story about how he wouldn't even move his car for the heavy machinery to --

AR: Do you remember when this conversation took place?

PN: Maybe five days -- five? It was last week?

MN: About a week ago.

PN: About a week ago.

AR: Okay. All right. So, you're talkin' to Dave about a week ago about --

PN: A chihuahua and a (Unintelligible).

AR: And since you're interjecting, your name? Maida?

MN: Maida, M-A-I-D-A.

AR: Your middle initial?

MN: J.

AR: Last name?

MN: Nichols.

AR: Your birthday?

MN: 9/12/1952.

AR: A good phone number for you?

MN: 941 --

AR: Uh-huh.
