INVESTIGATION

09/24/22 0738 Hours:

I received a call from Sgt. Surran #0712 requesting me to respond to a shooting that took place in the area of [REDACTED]

09/24/22 0814 Hours:

I requested the 911 calls from dispatch.

09/24/22 0834 Hours:

Upon my arrival, CSU Wafer #3126 was already present at the scene. We were briefed by Deputy Patella #2426 that a wife, later identified as Amy Gregory and her husband, David Gregory were walking their dog when they had an altercation with a known male,

Steven Colon. During the altercation, David fired his pistol and Steven sustained a bullet wound to the abdomen area and was transported to Sarasota Memorial Hospital. Steven was pronounced deceased at 0826 hours.

09/24/22 0851 Hours:

I conducted a sworn audio recorded interview with a witness, Gary Osgood. The following is a summary of the interview and is not verbatim. The recording was placed into evidence.

Osgood stated he lives at 1801 Highland Rd., Osprey. The morning of the incident, about 10-15 minutes prior to the 911 call, Osgood was walking his dog when he saw Dave and Amy walking their dog. Since their dogs do not get along, Dave and Amy walked towards the Bentley Hotel, and Osgood went the opposite way.

As Osgood was walking back to his house, he heard two gun shots and someone say "mother fucker." After hearing the gun shots, he saw Steven stumble and fall. Osgood went to his house to put away his dog and then went to assist Steven. Osgood observed Steven in the ditch and directed deputies to Steven. Osgood did not observe Dave and Amy in the area.

Osgood described Steven as a 24/25-year-old who has mental health problems. Osgood stated, Steven caused lot of problems with the homeowner association and their community. Osgood stated Steven does not leave the house much but walks around the neighborhood late at night.

Osgood stated recently he had an issue with Steven not moving his vehicle so workers can fix the community driveway. Osgood had to call Steven's mother to assist them since Steven had mental health issues. Osgood went into the house with Steven's mother and observed pill bottles along a tray that had a spoon with powder on it.

Osgood stated, Dave and Amy have had confrontations with Steven prior to this incident. Steven previously spit on Dave and Amy and took a fighting stance to Dave. Osgood knows since these confrontations with Steven, Dave carries a concealed weapon.

Osgood stated, Steven had another altercation with a neighbor named Toby. Steven became aggressive with Toby but when Toby confronted Steven, Steven ran away.

Osgood gave me contact information for Steven's mom, Paola Colon 941-441-8229, and Steven's father, Steven Colon [REDACTED].

09/24/22 0910 Hours:
