INVESTIGATION:

09/24/2022 0744 – 1223 hours:

Sgt. J. Friday #2488 sent me a text message on my department cellular phone asking if I could come and help with a shooting investigation.

I was unaware of the request until I viewed my cellular phone around 0943 hours and replied asking if I was still needed. Sgt. Friday advised that help was needed with neighborhood interviews, and I asked where I was needed. Sgt. Friday sent relevant information and I responded to the scene a short time later around 1012 hours.

I arrived on scene around 1014 hours and met with Sgt. Friday and other on scene personnel. After meeting we all had our responsibilities outlined I started attempting to contact residents on Shoreland Dr. and Highland Rd.

The results of those efforts on Shoreland Dr. are as follows in numerical order of address:

- 3 Shoreland Dr. – No answer. Left business card with request to call.

W/M Joseph H. Cockey 12/16/62 (941) 350-7415 – Called back later...

- 7 Shoreland Dr. – No answer. Left business card with request to call.

W/F Cynthia Louise Burry 12/6/74 (717) 917-5505 – Called back later...

- 15 Shoreland Dr. – Contacted and spoke with the following:

A/F Meng Meng 2/16/76

Mr. Li and Ms. Meng were not aware of the incident and did not have any information to provide about the involved parties otherwise.

- 19 Shoreland Dr. – Contacted and spoke with the following:

W/F Susan Marie Gordos 5/6/59 (440) 708-3690

Ms. Gordos said she was not aware of the incident but was somewhat familiar with the involved parties. She said that she had never seen any specific interactions between the involved parties but described Mr. and Mrs. Gregory as nice friendly people. She also described Mr. Colon as being "on the spectrum". Ms. Gordos said she has seen them while she is out walking.

- 23 Shoreland Dr. – Contacted and spoke with the following:

Mr. Wells said he was aware of the incident but did not witness anything. He also said he was somewhat familiar with the involved parties. He said he had interacted with the Gregory's and they were a "nice old couple". He said he hadn't interacted with the other involved party, but offered that heresy indicated and or suggested he was "psychotic".

All parties were neither aware of the incident nor familiar with those involved in it.

The Bielen's were aware of the incident due to Isiah Purcell coming over to their residence after it occurred. Isiah's mother, Dana Purcell (508-479-3966), was the primary complainant to 911 in this incident.

I did not speak with Isiah about the incident because his mother was unavailable, and the Bielen's were acting as his parentis in loco currently and did not think it was appropriate without his mother's blessing.

Mrs. Baiamonte said that she heard what she thought was some metal clanging around the time of the incident but did not directly witness anything. She also said that she didn't have any other information to provide on the involved parties.

Mr. Baiamonte did not have any direct witness account of the incident this morning but was somewhat familiar with the involved parties. He offered that Mr. Colon was "not with it".

- 104 Shoreland Dr. – Originally no answer. Left business card with request to call. I received a call from a resident and contacted him around 1130 hours.

Mr. Isard advised he had no knowledge of the incident or involved parties.

The results of those efforts on Highland Rd. are as follows in numerical order of address:

Mr. Higgins said he was not home at the time of the incident and didn't have anything to offer on the involved parties as he was relatively new to the neighborhood.

09/24/2022 1225 hours:

I received a call from Joseph Cockey, resident of 3 Shoreland Dr., but I was unable to speak with him at this time. I told him I would call him back.

09/24/2022 1247 hours:

I called Mr. Cockey back and he said he did not have any information to provide on the incident or involved parties.

09/24/2022 1258 hours:

I attempted to make phone contact with Mr. Hietalati of 1795 Highland Rd. reference the Ring Camera at his residence.

The call went unanswered, so I left a message clearly identifying myself, providing my contact information, and requesting a return call.

I followed the call up with a text message at 1302 hours, and specifically requested information that may be available via his Ring Camera.

09/24/2022 1320 hours:

I transported the Gregory's back to their residence from Sheriff's Office Headquarters.

I explained to them that I was not going to speak with them about the case and we had general casual conversation on the way back to their residence.

I did notice that both were very upset about what occurred, as visible and expressed. Mr. Gregory also was complaining about how sore his left arm was.

Ultimately, I dropped them at the front door to their residence around 1336 hours.

This ended my involvement with this case on this date.

09/24/2022 1338 hours:

Shortly after dropping the Gregory's off at their residence, I received a return call from Mr. Hietalati.

He advised that he had reviewed the information on his camera and that it didn't record any information during the time in question.

He elaborated that he had the settings managed so that it only captured things very close to his residence as to not receive unnecessary notifications. He also advised that the camera did have audio, but that the audio didn't record unless it was tripped by motion first.

09/24/2022 1651 hours:

I received a phone message from Cynthia Burry who resides at 7 Shoreland Dr. She advised that she was at work all day and didn't have any information to provide on the incident.

09/25/2022 1141 hours:

I received a phone message from David Black of 1811 Highland Rd.

He advised that they were out of town and could be contacted now that they are back in town.

09/26/2022 0945 hours:

I received a phone message from Steven Brownfield of 112 Shoreland Dr.

He advised that he didn't witness the incident.

He also said that anything he had to offer was heresy. The heresy he did offer was that many were fearful of Mr. Colon due to him being threatening, confrontational, and a nuisance. He described the Gregory's as the nicest people in the world.

09/26/2022 1201 hours:

I made phone contact with Mr. Black and confirmed that he was out of town and didn't have any information on the incident.

He said he had met the Gregory's while they were walking their dogs and just exchanged casual hellos.

He said he had never met Mr. Colon but heard him lifting weights before.

09/26/2022 1253 hours:

I attempted to contact with Ms. Burry of 7 Shoreland Dr. by phone.

The call went unanswered, so I left a message with appropriate information and requested she call or text back if she had anything else to add.

09/26/2022 1322 hours:

Due to the content of the message left on my phone by Mr. Brownfield of 112 Shoreland Dr., I forwarded the voice recording to Det. N. King for his review.

09/26/2022 1327 – 1334 hours:

Ms. Burry texted me back that she has no direct knowledge of the incident or involved parties.
