SYNOPSIS

I was dispatched 1507 2nd Street, on 02/09/2023, at 1223 hours, regarding a battery in progress between two white males. A white male wearing a blue shirt and jeans who was later identified as Jody Belli and a white male in a wheelchair later identified as Douglas Peabody.

LOCATION / SCENE DESCRIPTION

1507 2nd Street (Sidewalk)

STATEMENTS

Witness - Justin Kloer - Stated that as he was outside City Hall on his break. He witnessed a white male wearing a long sleeve denim top and blue jean pants approach an elderly white male in a wheelchair. Kloer witnessed Belli cross the street and run towards Peabody. As Peabody was attempting to wheel himself West on the sidewalk, Belli grabbed the wheelchair handles and started pulling him backwards. While still behind Peabody, Belli reached his right arm around Peabody's neck, apparently choking him. Kloer stated that he could hear Peabody screaming to "stop" and "get off me". Kloer began to approach the altercation, telling Belli to stop. Belli stopped and then ran towards Kloer. Belli kept making aggressive and threatening movements towards Kloer, yelling and screaming at him. Kloer then took out his phone and contacted 911.

Victim - Douglas Peabody - Stated that he had been attempting to pick up his belongings from the sidewalk and go to the SCAT station. As he was headed West, Belli ran over towards him. Peabody stated that Belli was yelling at him and saying that he was going to "take all of his shit". Belli physically stopped Peabody from leaving the area and attempted to grab at and inside of his front pants pockets. When Peabody moved his hands away, Belli reached around from behind him and choked him with his arm. Peabody stated that it felt like Belli was stopping him from breathing. When Belli released him, Peabody started leaving the area attempting to get away from him. Peabody did not believe that Belli has successfully taken anything from him. Peabody stated that he wished to press charges for the incident.

Defendant - Jody Belli - Stated that Peabody had left his belongings on the sidewalk. He had attempted to pick up Peabody's belongings for him. When Peabody saw Belli touching his belongings, he began yelling at him from across the street. Belli then ran across the street and attempted to hug Peabody from behind. Belli stated that he gently reached his right arm around Peabody and hugged him. Belli stated that Peabody is his friend and he would never attempt to harm him or steal from him. Belli stated that he had even bought Peabody lunch today.

INVESTIGATION / CANVAS / EVIDENCE

Officers arrived on scene and placed Belli into custody. A show up was conducted where Peabody confirmed that Belli was the subject that had grabbed him and attempted to take his money. Photo's were taken of Peabody and uploaded via Axon Capture. There were no visible injuries to Peabody, he stated he did not require medical attention. Belli stated that since being in handcuffs he felt like something was medically wrong with him and requested EMS respond. EMS arrived on scene and transported Belli to Sarasota Memorial Hospital for a medical evaluation. (((Belli was then transported to the SSO Jail for Robbery, FSS 812.13(3)(a).)))

CASE DISPOSITION / CRIME ELEMENTS

Belli was transported to the SSO Jail from SMH without incident. Peabody was provided a Victim's Rights Brochure, Marys's Law Pamphlet and Victim Notification Card. Case closed/inactivated.
