Officers responded to 202 N Tamiami Trail (Embassy Suites) on 2/11/23 in reference to a felony battery. Officers contacted the victim, , who advised she was struck in the face by a subject, Keith Gray. advised she was attempting to retrieve her cell phone from Gray's vehicle, that was parked inside the garage at the location. stated that Gray was refusing to allow her access to his vehicle to retrieve her phone. advised her husband. Michael Callahan, entered into an altercation with Grav. stated that Callahan was only attempting to "control" Gray, and that Gray placed Callahan in a headlock. advised that she attempted to break Gray and Callahan apart, and was eventually successful. stated that Callahan was able to retrieve phone from Grav's vehicle. advised that after she got her phone back. and Callahan separated from Grav. stated that Gray then approached her, and without being provoked, struck her in the face. advised the strike briefly knocked her unconscious and she fell the the ground. stated as a result of the strike from Gray, her front tooth was chipped in half. advised she wished to pursue charges against Gray.

husband, Michael Callahan, advised that he was at the location with sector and her friends. Callahan stated that advised she could not locate her phone, and when they used GPS to locate it, it showed that it was in Gray's vehicle. Callahan stated Gray then struck gray in the face.

Gray's girlfriend, Blake Vallaire, stated she was at the location with the above mentioned parties. Vallaire advised they were going to depart from the location, when she was informed by that she could not find her phone. Vallaire "pinged" that gray allow him to retrieve and determined that it was inside Gray's vehicle. Vallaire stated Callahan confronted Gray, requesting that Gray allow him to retrieve phone. Vallaire advised a verbal altercation ensued between Callahan and Gray, and it eventually escalated into a physical altercation. Vallaire stated herself and the managed to break Callahan and Gray apart. Vallaire advised Callahan and Gray were separated, and the began verbally arguing with Gray. Vallaire advised Gray then struck the face.

SCFD responded and treated **and treated for her injuries.** Officers observed bruising to **a second s**

Officers observed Gray walking northbound on the sidewalk near the location. Officer Kenniston contacted Gray, and placed him into handcuffs. Gray was read his Miranda Rights, and agreed to speak with officers. In reference to this incident, Gray stated

Officers spoke with the employees of the location, who advised that there are security cameras inside the garage, however they are unable to access them at this time. Follow up to be conducted.

Gray had minor bruising above his right eye, and a cut on his nose, presumably from his altercation with Callahan. Gray insisted that it was due to an unknown subject attacking him from behind. Pictures uploaded via Axon Capture.

Probable cause exists for the violation of F.S.S. 784.041(1)(a) Felony Battery by Keith Gray because Gray actually and intentionally struck against her will, and Gray caused against permanent disfigurement (broken tooth). Gray was placed under arrest and transported to SSO jail without incident.

The above occurred within the City of Sarasota. This incident was captured via my department issued body worn camera (BWC).
