Officers responded on 3/14/23 to 1572 31st St in reference to a juvenile, Ladarius Goodman-Mills. Mills was recently reported missing (ref case 23-011969) and his guardian, Diane Jenkins, contacted law enforcement to advise Mills had returned to the location. Mills is known to have an active warrant out of Sarasota County for Failure to Appear – Ct1 Burglary of Unoccupied Conveyance, CT2 Motor Vehicle Theft, CT3 Possession of Burglary Tools (Warrant 2023 CJ 000123).

Upon arrival, Officers immediately observed Mills on the front porch of the location. Officers contacted Mills, and Officer Sullivan attempted to detain Mills. Mills immediately backed away from Ofc Sullivan, and attempted to flee from officers. As Mills was trying to flee, I grabbed Mills around the waist in an attempt to control him. Mills continue to pull away from me, and thus I conducted a take down. Once on the ground, Ofc Sullivan and I attempted to place handcuffs on Mills. Mills continued to resist, by pulling against officers' grasp. Eventually I was able to place and double lock handcuffs on Mills.

When Officers attempted to transport Mills to the patrol vehicle, he dropped his weight and refused to walk. I utilized a transporter hold on Mills' right arm, and aided Ofc Garcia in carrying Mills to the patrol vehicle. Mills continued to resist as officers were trying to place him in the patrol vehicle. During the process, Mills kicked Ofc Garcia in the waist area three times. As Ofc Garcia was conducting a search of Mills' person, Mills attempted to exit the vehicle and I grabbed Mills' right arm and lifted him back inside the vehicle. After successfully placing Mills inside the vehicle, he began aggressively kicking the window and door frame repeatedly. Probable Cause exists for the violation of F.S.S. 843.01 Resist Officer with Simple Assault by Ladarius Goodman-Mills because Mills knowingly and willingly resisted Ofc Garcia by doing violence to him. At the time, Ofc Garcia was engaged in the lawful execution of legal duty. At the time, Ofc Garcia was an officer and Mills knew Ofc Garcia was an officer.

Mills was transported to SSO jail without further incident. His guardian, Diane Jenkins, was notified of his arrest.

The above occurred within the City of Sarasota. This incident was captured via department issued body worn camera (BWC).

NARRATIVE

On 3/14/23 at 1452 hours, I responded to 1527 31st St. to assist Ofc. K Sullivan and Ofc. Gregorio with the arrest of Ladarius Goodman-Mills.

Mills was already in custody when I arrived on scene and proceeded to assist with escorting him to Ofc. K Sullivan's patrol vehicle. Ofc. Gregorio and I stood Mills up and he began resisting and pulling away from us. I placed my arm under his left arm through the arm pit area and walked him to the vehicle. Since Mills was refusing to get in the vehicle and resisting, Ofc. Gregorio and I lifted into the vehicle. I did this by grabbing the bottom of his jean shorts near his knees and lifted his lower body while Ofc. Gregorio lifted his upper body.

While in the patrol vehicle, I began searching Mills' pockets. As I did so, Mills became more irate and began kicking and thrashing, which prompted me push his upper right arm away from me to stop him. Mills slipped off the seat which required me to lift him again using his legs. I placed a seatbelt on Mills' and closed the door. Mills then started kicking the door window and I opened it to stop him from doing so. I opened it and as I got closer to him, he began kicking me below the waist area. I held Mills' right leg and right shoulder while pushing back to cease his kicking. I tried to calm Mills down but I was unsuccessful and it was decided that Ofc. K Sullivan would transport Mills to the SSO Jail despite Mills kicking.

I followed behind Ofc. K Sullivan's patrol vehicle with mine until we arrived at the jail.

NARRATIVE

In reference to this case, Officer Gregorio and I contacted B/M Juvenile Ladarious-Goodman-Mills. Mills was reported as missing, and also had an active felony warrant for his arrest when contacted.

I approached Goodman-Mills and informed him that he had to come with us. Goodman-Mills then attempted to flee from officers on foot. Ofc. Gregorio was able to tackle Goodman-Mills in the front yard of the incident residence to prevent him from escaping. I then used my right knee and shin to pin Goodman-Mills left arm behind his back while holding both of Goodman-Mills wrists behind his back for handcuffing.

Officer Garcia arrived on scene shortly after, and assisted in the arrest. As Officer Garcia and Ofc. Gregorio were placing Goodman-Mills into my patrol vehicle, I observed a crowd gathering in the front yard of the residence. I spoke with members of the crowd to de-escalate the situation.

Goodman-Mills was transported to the juvenile intake facility. I observed no injuries to Goodman-Mills during or after the incident, and he reported to J.A.C. intake staff he was uninjured.

The events were recorded on body worn camera.


