On 09/29/2023 at approximately 0933 hours the defendant, Earl Hamilton, did make an illegal drug sale. The defendant did sell one (1) piece (.2 Grams) of rock cocaine to Sarah Burris in exchange for \$20.00 in pre-recorded U.S. currency, which was given to her from and undercover police detective.

Writer gave Burris \$20.00 of pre-recroded U.S. currency to which she walked and met with the defendant. Burris and the defendant then conducted a "hand to hand" drug transaction, to which the defendant gave Burris one pieces of rock cocaine for the \$20.00 of pre-recroded U.S. currency that Writer gave Burris. Burris then brought the rock cocaine back to Writer. The transaction was recorded using covert audio and video recording capabilities.

The cocaine was field tested with a positive result. This crime did occur within 1000 feet of Sarasota School - Arts and Science located at 717 Central Avenue, in the City of Sarasota. The defendant was not arrested due to an ongoing investigation.
