Call Synopsis, Address, and Location Description:

On 12/27/2023 at approximately 0932 hours, I responded to 1844 17th St in reference to a subject with an active felony warrant. The Probation officer detained the subject while officers were enroute and the warrant was confirmed. Search incident to arrest, officers located two cigarillo packets containing suspected Methamphetamine and a small bag with a similar crystallized powder. A field test was conducted which showed positive for Methamphetamine. The subject was subsequently arrested for the active warrant and charged with F.S.S. 893.13(6)(a)- Possession of a controlled substance- Methamphetamine. The subject was transported to SSO jail without issue.

Investigation:

I responded to the above location (Florida Department of Corrections) in reference to a female subject with an active warrant out of Sarasota County. Ofc. McCracken detained the female, Jeanine Stanford while the warrant was confirmed.

The warrant was confirmed for Jeanine Stanford for VOP: Petit Theft Third or Subsequent (2022CF008831).

I conducted a search of Stanford's person prior to transport. In Stanford's front right pocket of her jeans was two cigarillo packets, a small clear bag, and a lighter. Stanford immediately stated the pants she was wearing do not belong to her. Inside the larger cigarillo bag was tobacco leaves with small clear crystals consistent with Methamphetamine. Inside the smaller cigarillo bag was white powder residue. Inside the small clear bag was a small crystallized powder. A field test was conducted on the powder located in the small clear bag which tested positive for Methamphetamine. While testing the suspected narcotics, Stanford stated the narcotics are not Methamphetamine, they are "molly". Stanford denied the narcotics belonged to her.

The items located on Stanford's person were placed in SPD property as evidence.


